Long-standing ethical principles for genetics research help respect and protect research participants, and they are especially important for preventing harm to marginalized or vulnerable populations. In a new <u>AJHG Perspective</u> out this month in *The American Journal of Human Genetics*, ASHG articulates expectations that scientists worldwide abide by universal ethical standards for biomedical research. 

#### **Congressional Champion for Biomedical Research Dies**



<u>Lawmakers</u> of both parties are <u>paying tribute</u> to former Rep. John E. Porter, an Illinois Republican and Appropriations "cardinal" who died on June 3 at the age of 87. As chairman of the House Labor-HHS-Education Appropriations Subcommittee, Porter led a push to double funding for the NIH; his support for research paved the way for the mapping of the human genome. Research!America also <u>paid tribute</u> to Porter, who served as member and chair of their Board after leaving Congress. ASHG is a member of the Research!America advocacy alliance.

### In Other Policy & Advocacy News

- In the wake of the hate-fueled mass killing in Buffalo, NY last month, ASHG President,
   Charles Rotimi, PhD, released a <u>statement</u> condemning the warping of genetic knowledge to feed racist ideology.
- The <u>Rally for Medical Research</u> is back on in-person this year! Join other advocates on Sept. 13-14 as we continue to call on our nation's policymakers to make NIH funding a national priority.
- ASHG has joined the <u>Coalition for the Life Sciences</u>! Our Board representatives are Nancy Cox, PhD and Anthony Wynshaw-Boris, MD, PhD.
- President Biden <u>announced</u> the nomination of Arati Prabhakar, PhD, a physicist and former head of the Defense Advanced Research Projects Agency, as his science advisor and director of the White House Office of Science and Technology Policy.
- HHS Secretary Xavier Becerra <u>announced</u> the formal establishment of the Advanced Research Project Agency for Health (ARPA-H) as an independent entity within the NIH, and the appointment of Adam H. Russell, D.Phil., as acting deputy director beginning this month.

- NASEM <u>held</u> the third public online workshop on Use of Race, Ethnicity, and Ancestry as
  Population Descriptors in Genomics Research on June 14. The recording and meeting
  details will be <u>available here</u>.
- If you registered for the <u>5th ELSI Congress</u> but missed a live session, <u>recordings</u> are now available.
- The U.S. House of Representatives <u>adopted</u> a deeming resolution in early June, setting a \$1.6 trillion discretionary spending cap for fiscal year 2023 appropriations. This clears the way for appropriators to start moving the spending bills through the House.
