ASHG Submits Testimony to Appropriations Committees



Brendan Lee, MD, PhD, ASHG President-Elect, submitted written testimony to Congress on behalf of ASHG this month. In his testimony, Dr. Lee describes the extraordinary progress in human genetics and genomics research, urging Congress to appropriate \$49 billion for NIH's base budget in Fiscal Year 2023, with funding for the newly established Advanced Research Projects Agency for Health (ARPA-H) to supplement that investment in NIH's base budget.

In Other Policy & Advocacy News

- ASHG signed on to the Ad Hoc Group for Medical Research's <u>NIH funding recommendation</u> for Fiscal Year 2023 and Research!America's <u>letter</u> urging congressional leaders to provide a robust funding allocation this year for medical and public health research.
- The <u>5th ELSI Congress</u> on ethical, legal, and social implications of genetics research will be held from **May 31 June 3, 2022**. Registration for this event is free and <u>available here</u>.
- The <u>third meeting</u> of NASEM's Committee on Use of Race, Ethnicity, and Ancestry as Population Descriptors in Genomics Research will be held on **June 14 - 15, 2022**. Our summary of the previous meeting is <u>available here</u>.
- Sudip Parikh, PhD, CEO of American Association for the Advancement of Science (AAAS), recently <u>contributed to an article</u> posted in *The Hill* on the importance of federal investment in science; the article cites the 2021 ASHG/TEConomy <u>report</u>.
- NASEM's Committee on <u>Improving the Representation of Women and Underrepresented</u>
 <u>Minorities in Clinical Trials and Research</u> released its <u>report</u> this month.
- NIH <u>has announced</u> that institutions will be required to report when a PI or other key
 personnel on a NIH-funded award has been removed from their position or otherwise
 disciplined for harassment or bullying. The policy becomes effective on 7/8/22; <u>Science</u>
 reports that some hope the new policy would have gone further.
- Rep. Kweisi Mfume (Maryland's 7th District) recently introduced <u>H.R. 7091</u> to award posthumously a Congressional Gold Medal to Henrietta Lacks, in recognition of the invaluable contribution of her immortal cells to scientific research and patients' rights.
- The U.S. Government Accountability Office (GAO) released <u>recommendations</u> in late April for federal scientific agencies to define political interference in scientific decision-making and describe how it should be reported and addressed.
- A <u>Committee</u> of members of the U.S. House of Representatives and Senate has been established to reconcile the differences between the America COMPETES Act and the U.S. Innovation and Competition Act.
