# About the Organization

The American Society of Human Genetics (ASHG or the Society) is the world's largest professional organization for human genetics and genomics, one of the most dynamic and essential drivers of progress in research, biotechnology, and health. The Society envisions a future in which people everywhere realize the benefits of human genetics and genomics research and works to advance human genetics and genomics in science, health, and society through excellence in research, education, and advocacy. Founded in 1948, it is the primary professional membership organization for human genetics and genomics specialists worldwide, including a vibrant and diverse community of 8,000 researchers, academicians, clinicians, laboratory practice professionals, genetic counselors, and others with an interest in human genetics. Over time, the Society has grown, integrating new communities and specialties within human genetics. Today, the human genetics and genomics community spans scientific and clinical disciplines, reaches worldwide, and engages public and private sectors.

ASHG marks its 75<sup>th</sup> anniversary in 2023 with the motto "One Humanity, Many Genomes." Over the three quarters of a century since its founding, there have been countless breakthroughs in research, diagnostics and treatment, collaborations around the world, and lives changed for all people due to genetics and genomics research. Genetic discoveries have transformed fundamental understanding of DNA structure and function and propelled revolutionary tools and therapies, enabling new knowledge and new ways to prevent, diagnose and treat disease ever more effectively. These discoveries are also affirming humanity's common ancestry and extraordinary genetic similarity, while enabling the investigation of the small but impactful variations between populations that can influence disease risk and resilience. The Society has also supported important dialogue about the ethical, legal, and social implications of genetic research to inform responsible application of this knowledge.

The Society's programs center on: 1) providing forums to share research results through the <u>ASHG Annual Meeting</u>; a host of year-round online professional education mechanisms; and in its journals, The <u>American Journal of Human Genetics</u> and <u>Human Genetics and Genomics Advances</u>; (2) advancing genetic research by advocating for federal research support and policies that support the field and community; (3) educating current and future genetics research professionals, students, and the public; and (4) promoting responsible social and scientific policies. Diversity, equity and inclusion are high priorities across all ASHG programs and the Society has substantially increased DEI focus in its scientific forums, governance, workforce development, and public advocacy and policy programs.

ASHG is a financially secure, strategic, operationally modern organization committed to shaping the future of its community's transformative research. The Society navigated the pandemic period successfully and its FY24 revenue budget is \$9.6 million with reserves valued at approximately \$19.5 million. Headquartered in Rockville, MD, most of its 32 professional staff reside in the Washington metropolitan region. A 501(c)3 organization, ASHG's Board of Directors is comprised of 18 members.
