Take Action

Shutdown Avoided; Government Funded into Early 2024



With a new Speaker of the House, Rep. Mike Johnson (R-LA-04), elected at the end of October, Congress has been able to resume work on FY2024 appropriations. As the initial continuing resolution (CR) that kept the government funded after September 30 expired last month, Congress has now punted the appropriations bill deadlines into early 2024. On Nov. 16, President Joe Biden signed the Further Continuing Appropriations and Other Extensions Act, 2024 (H.R. 6363), passed by Congress on Nov. 15, which creates a two-tiered CR that would fund some federal departments and agencies through January 19, and extend other spending bills, including the Labor, Health and Human Services, Education and Related Agencies appropriations bill (which includes funding for the NIH), through February 2. President Joe Biden signed this CR just one day before the government was set to shut down, giving

Congress more time to negotiate funding levels for various government agencies, including the NIH, for FY2024.


