August Recess Wrap-Up: What's Next for NIH Funding?



Congress will be back in Washington after the August recess soon, which means that the next phase of the FY26 budget negotiation process is about to start. Before recess, the Senate Appropriations committee proposed \$47.201 billion for NIH's base budget, a \$400 million increase compared to FY25. The House has yet to begin work on its version of the Labor, Health and Human Services, Education, and Related Agencies (LHHS) spending bill, while the Senate's version is still awaiting a full chamber vote. The House Appropriations Committee is expected to mark up its LHHS bill in early September, and both chambers must reach an agreement by the end of FY25 on September 30. As the end of Fiscal Year (FY) 2025 rapidly approaches at the end of September, these valuable conversations aim to keep momentum going and ensure that lawmakers understand the importance of robust NIH funding for all.
